ARTICLE I

Services of the "All Inclusive" package:

Part 1 – Services for the biological parents:

- 1. First visit (2 or 3 days) of the biological parents who will be met at the airport by the representative of Medicare4U
- 2. Providing biological parents with a comfortable accommodation during the entire stay.
- 3. The accommodation is supplied with all facilities such as: kitchen, refrigerator, shower, TV, comfortable bed, etc.
- 4. The first visit includes all the necessary alimentation. Also some local excursions may be organized in case there is some free time.
- 5. The first visit implies medical examination in a private clinic by the doctor in charge of the program.
- 6. Appointment of the surrogate mother and preparation of the contract between surrogate mother and future parents.



- 7. Preparation and signing of the contract between Medicare4U and prospective parents.
- 8. Service of an interpreter for the entire period of the program.
- 9. Providing with all the medical services required for the artificial insemination.
- 10. Coordination and monitoring of all personal documents concerning the program.
- 11. Coordination and control of all prospective parents' medical examinations regarding the program.
- 12. Coordination and supervision of the program until the birth of the child and preparation of all the necessary documents.
- 13. Keeping prospective parents informed about pregnancy progress (from Medicare4U) supplying them with all the relevant information at least once a month.
- 14. Second visit (from 5 to 10 days) for the embryos transplantation in the private clinic.
- 15. The second visit includes meals and the organization of local excursions, if requested.
- 16. Sonography should be made in the 3rd and in the 6th month of pregnancy.
- 17. The third and the last visit (2 weeks) during childbirth for the delivery and for execution and legislation of all the documents. The third visit includes accommodation in an apartment with all the necessary facilities.2
- 18. Assistance in the Ukrainian Register of Civil Proceedings, to obtain the child's birth certificate in the name of the biological parents.
- 19. Legal assistance to the biological parents in obtaining a passport in the name of the child.
- 20. Final accompaniment of the parents and the newborn to the airport for them to leave the country.

Part 2 – Services concerning surrogate mother and Legal Services:

- 1. Selection of the surrogate mother from the extensive database of Medicare4U.
- 2. Psychological diagnostic of the surrogate mother regarding her psychological state and her wish in participating in this program.



- 3. Medical examination of the surrogate mother to confirm the physical state available for fertilization, pregnancy and subsequent birth of a healthy child.
- 4. Defrayal of all the costs arising from the choice and preparation of the surrogate mother: medical needs, transportation, living, meals until she signs the contract with the prospective parents.
- 5. Defrayal of all the surrogate mother's medical analysis taken in the private clinic for artificial insemination.
- 6. Daily check-up by the company Medicare 4U. (by phone or personally) of the surrogate mother's health and physical needs during her pregnancy including any medical examinations.
- 7. All the ultrasound tests, authorized by the doctor of the private clinic, to ensure that both the child and the surrogate mother are in good health.
- 8. All the charges for the accommodation of the surrogate mother in her private room, the costs of childbirth, etc. are paid by the clinic.
- 9. Defrayal of all the costs concerning the work of private clinic's doctor.
- 10. Defrayal of all the costs concerning clinic's nurse, responsible for the care of the child after birth.
- 11. Medical insurance for the surrogate mother in the event of unforeseen circumstances during childbirth or pregnancy.
- 12. The "All Inclusive" package includes the payment to surrogate mother for carrying the pregnancy of your child.
- 13. If requested, a separate DNA test can be done to confirm the parenthood. (The cost of the service is paid by customers).
- 14. The blood sample should be obtained from the umbilical cord and stored for a period of 3 years.
- 15. The package includes all the services of legal assistance in the event of remote cases concerning surrogate mother.
- 16. Official registration of the documents concerning the birth of the child at the Ukrainian

Civil Registry of Acts, until it issues the birth certificate, in which the names of the genetic parents are listed. Translation and legalization of the birth certificate are also included. 3

A positive result of pregnancy is a pregnancy that reaches the period of 12 weeks. Due to the terms of the agreement, if the patient has a miscarriage before 12 weeks of pregnancy, we guarantee the resumption of attempts.



The company Medicare4U, the private clinic, the surrogate mother, and all parties are subject to confidentiality and will not disclose any information about the identity of biological parents or born child to third parties.

ARTICLE II

The cost of the "All Inclusive" package:

- The price of the "All Inclusive" package is 29.900 euro (may vary depending on the euro course). The price covers the cost of all the services listed above, including all needed medicine.
- The payment of the program is divided in 5 rates listed below:
- 1. 20% is the first instalment, which should be paid during the first arrival in Ukraine after signing the contract.
- 2.20% at the second visit (no more than three months later) before taking of the client's semen and transferring of the embryos.
- 3.20% is the third instalment that should be paid after three months of the pregnancy.
- 4. 20% should be paid after the birth of the child.
- 5. 20% is the last instalment to be paid after receiving of the child's birth certificate and getting assistance in receiving of a passport for a child to leave the country.

For your consideration:

- Please note that Medicare4Uworks closely with embassies, and the last payment should be paid only after you (the genetic parents) receive the passport in the name of the child. The last instalment should not be paid until you get a valid passport.
- Medicare4U is responsible for all legal part.
- Note that the "All Inclusive" package implies ovodonation of the embryos and guaranties a positive result, no matter how many attempts are needed, all of them are to be paid by the company Medicare4U.



- The "All Inclusive" package cost includes all the payments connected to the parties and their services. In the unlikely event of losing a child by the surrogate mother, payments that have been already made are not affected. The cost of finding a new surrogate mother should be paid by the company. In this case, the biological parents only pay for air tickets.
- In case payments are made by a bank transfer, a photocopy of the bank's transfer agreement should be sent by email.
